Dear Sir,

Piease refer to your letter dated 13<sup>th</sup> August 2012 appointing me as the Scrutinizer for the purpose of ascertaining the result of the above said resolutions passed by means of Postal Ballot process.

As per the information furnished to me by the Company and after carrying out the scruting of the Postal Ballot Forms received from the members of the Company, I hereby submit my report as under:

1.1 The Company, on 17<sup>th</sup> August 2012, completed the dispatch of Postal Ballot Forms along with self addressed postage prepaid envelopes to its Members whose name(s) appeared on the Register of Members/list of beneficiaries as on 10th August 2012. A public advertisement to that effect was given on August 21, 2012.

- 1.2 The Public Advertisement with respect to dispatch of postal ballots was published on August 21, 2012.
- 1.3 In terms of the Public Notice, the last date and time fixed to receive the Postal Ballot Forms from the members was not later than close of working hours (i.e. before 5.00 PM) on Tuesday, 18th September 2012.
- 1.4 Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
- 1.5 The postal ballot forms were kept under the safe custody in a sealed and tamper proof ballot box.
- 1.6 The postal ballot forms was opened on Tuesday, 18th September, 2012 at 8.00 p.m. in my presence and scrutinized. The shareholding was matched /confirmed with the Register of Members of the company/list of beneficiaries as on 10<sup>th</sup> August 2012 as maintained by the Company.
- 1.7 All postal ballot forms received upto 5.00 PM on Tuesday, 18th September, 2012, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- 1.8 Envelopes containing postal ballot forms received after 5.00 PM on Tuesday, 18th September, 2012, were not considered for my scrutiny.
- 1.9 3280 Envelopes containing postal ballot form were returned undelivered.
- 1.10 I did not find any defaced or mutilated ballot papers.
