Effective August 14, 2012, the Company has closed operations at Raigad Processors and has retrenched all surplus workmen at Konkan Synthetic Fibres. The total expense towards the above amounting to Rs. 620 Lacs has been disclosed as an exceptional item.
- 4) Other Income for the year ended 31st March, 2012 includes Rs. 591 Lacs interest on income tax refunds.
- 5) Tax expense for the year ended 31st March, 2012 includes Rs. 853 Lacs excess provision in respect of earlier years written back on completion of assessments and receipt of refund orders.
- 6) The Statement of the Financial results has been prepared as per the Revised Schedule VI under the Companies Act, 1956. Accordingly the results for the quarter ended and nine months ended 31st December 2011 have been reclassified to conform to this year's classification.
