Re: Revision in the Disclosure in Form D made under Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 1992

I wish to bring to your kind notice that closing balance of total number of shares held as per disclosure made on 18.02.2013 and opening balance of total numbers of shares held as per disclosure made on 20th August 2013 have not tallied due to corrections of typing/ inadvertent errors and omission to report the allotment made on operationalization of the scheme of amalgamation of Jyothy Consumer Products Limited ('JCPL') with the Company as approved by the Bombay High Court.

The revised Form Ds in respect of the same are attached herewith for your kind reference and records.

The Details in respect of which revisions have been made are as under:

Form D dated 14.02.2013: There was a typo-error in the opening holdings as per Form D dated 14.02.2013 i.e. total shares held before acquisition disclosed as '84316' instead of 84136 which resulted in excessive reporting of 180 shares in the Form D dated 14.02.2013, 15.02.2013 and 18.02.2013. The same have been corrected vide revised disclosures in Form D.

Form D dated 15.02.2013: As per the above paragraph, only consequential changes in the total number of shares held before acquisition and after acquisition. The same have been corrected vide revised disclosures in Form D.

Form D dated 18.02.2013: There were two transactions for acquisitions of 4,337 shares and 2,000 shares respectively through different trading members. However due to inadvertence, the later transaction for acquisition of 2,000 shares was missed out in the disclosure made on 18.02.2013. The same has been corrected in the revised disclosures in Form D

Form D dated 20.08.2013: On 13th August, 2013, my demat account was credited with 21,276 shares on account of shares issued against my holding in JCPL pursuant to operationalization of the scheme of amalgamation of JCPL with the Company as approved by the Bombay High Court. The intimation in respect of the same was received by me at later date. Hence the same was missed out from the reporting in the disclosure dated 20.08.2013. The same has been corrected in the revised Form D.

I would like to submit that the above errors were unintentional and occurred due to inadvertence and oversight out of two trading accounts. I regret the inadvertent error and the inconvenience caused. I shall take due care and diligence to avoid such recurrence in future.

I further confirm and declare that disclosures, both before and after purchases, after 20.08.2013 are correct.
