71 members and 5 proxy holders attended the meeting.

Necessary quorum being present the meeting commenced.

At the request of other directors present, Shri Satish R Shetty presided as Chairman for the meeting ("Chairman") and conducted proceedings.

Chairman welcomed members for the 30th Annual General Meeting of the Company.

With the consent of members present the Notice of the Annual General Meeting was taken as read. Company Secretary read the Auditors Report.

Shri Satish R Shetty delivered the welcome address to the members and explained about the Company's performance in brief as follows:

Financial Performance

Your Company has earned an income of ₹14,475.95 lakhs. The expenses of the Company were ₹11,328.65 lakhs. Expenses were in tune with the revenue. Finance Cost and Depreciation/amortization expenses were ₹2,155.77 lakhs and ₹903.12 lakhs respectively. Profit before tax was ₹88.41 lakhs and after tax was ₹83.71 lakhs. Your Company has adopted various cost cutting measures and good marketing strategies to increase the profits in the mere future.

Business Promotion

New technology such as Digital tiles Technology, Nano Technology, Water Jet Technology productions are catching up as the customer always look for innovative tiles. Cladding in a technology is also picking up in the market. These tiles goes well on exteriors such as lobby or staircases. The somerset

The R & D team is work hard to invent new product range, designs and sophisticated colors. Apart from big builders for bulk orders, we are concentrating on small builders and dealers also.

Your Directors are hopeful of achieving better results in the year 2013-14.

Preferential Allotment of shares and convertible share warrants

During the year your Company has issued 19,35,000 equity shares on 19.03.2013 and 20, 35,000 equity shares on 30.07.2013 by converting the Convertible Share Warrants into equity shares to Murudeshwar Power Corporation Limited and the amount arrived was utilized for repayment of debts and working capital purposes.

Current year performance

Your Company during the first quarter of 2013-14 has earned an income of ₹ 3,532.76 lakhs and incurred an expenditure of ₹ 3,501.74 lakhs. Your Company has earned an after tax profit of ₹ 24.71 lakhs. Your Directors is expecting more profits in the coming quarters.

Prospects

The Company is expecting a better growth in the mere future since the Karaikal unit is functioned with improved gas allocation. Liquefied Natural Gas (LNG) allocation for Hubli Unit is expected to arrive by December 2013.. The Management is constantly exploring various ways to reach rural areas, since demand in rural areas is increasing constantly. Advertisement and Publicity is under the control of professional team.


