We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity." A review of interim financial information consists of making inquiries, primarily of persons responsible of financial and accounting matters and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standard on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit.

We did not review the un-audited financial result of Zullinc Healthcare Ltd, a wholly owned subsidiary and Lincoln Parenteral Ltd a subsidiary whose financial result reflects total loss of Rs. 36.23 Lakh and assets of Rs 2509.97 Lakh for the quarter ended on that date. These un-audited financial statements have been reviewed by other auditor whose report has been furnished to us and our opinion, in so far as it relates to the amount included in respect of the said subsidiaries, is based solely on the report of the other auditor.

Based on our review, nothing has come to our attention that causes us to believe that the accompanying interim financial information is not prepared, in all material respects, in accordance with Companies (Accounting Standards) Rules 2006, except a short provision to the extent of Rs. 154 Lakh toward unsecured trade receivable considered as doubtful.
