Dear Sir,

This is to inform you that the Board of Directors ("Board") of the Company vide its resolution dated 21 October 2013, had sought the approval of the shareholders of the Company by a special resolution, pursuant to Section 180(1)(a) of the Companies Act, 2013 read with Section 192A of the Companies Act, 1956 and the Companies (Passing of the Resolution by Postal Ballot) Rules, 2011 (as amended) by means of Postal Ballot and E-Voting as specified in the Postal Ballot Notice dated 21 October 2013, read with the Explanatory Statement attached thereto, for sale and transfer of the whole or substantially the whole of the Indian made foreign liquor business undertaking of the Company, by way of slump sale as a 'going concern' or otherwise, to a subsidiary of the Company.

The Board had appointed Mr. Niraj Preet Singh Chawla, LLB, ACS, Principal Associate of Vaish Associates Advocates, as scrutinizer ("Scrutinizer") for conducting the Postal Ballot and E-Voting in accordance with the provisions of the Companies Act, 1956 and the Companies Act, 2013. The duly completed Postal Ballot Forms were to be received by the Scrutinizer or before 5 PM on 9 December 2013. The Scrutinizer has submitted his report dated 13 December 2013 to the Chairman ("Scrutinizer's Report").

On the basis of the Scrutinizer's Report dated 13 December 2013, the Chairman of the Board or the person authorized by the Chairman of the Board announced on 13 December 2013 that the special resolution of the Postal Ballot Notice dated 21 October 2013, was duly passed by the requisite majority.

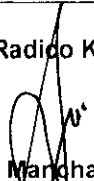
