- 1. The Board of Directors of the Company at its meeting held on February 14, 2013 has appointed me as a Scrutinizer for conducting the postal ballot voting process.
- 2. I submit my report as under:
 - a. The dispatch of postal ballot forms to the Members of the Company whose name(s) appeared on the Register of Members / list of beneficiaries as on February 22, 2013 along with postage prepaid envelope was completed on March 1, 2013.
 - b. Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose. Total 246 envelopes were received. Besides this the company has received 21 envelopes which contain the postal ballot forms of another company.
 - c. The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot box before commencing the scrutiny of such postal ballot forms.
 - d. All postal ballot forms received up to close on working hours on 6th April 2013, the last date and time fixed by company for receipt of forms were considered for my scrutiny.
 - e. The envelope received after cut off dates were not considered for my scrutiny.
 - The valid postal ballot forms and invalid postal ballot forms for Resolution No.1 and Resolution No.2 have been marked and unmarked serially.

The postal ballots forms in which signatures were mismatched have been rejected. Votas cast by these members have not been counted for declaring the result.
