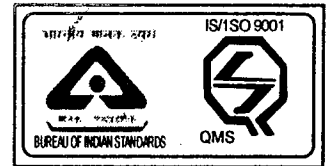

Please refer to our above letter intimating the receipt of Advance Purchase Order from BSNL for 3206 kms, supply of 24F HDPE Double Sheath OFC and on the expected Government's NOFN project order.

We are very glad to intimate that we have successfully executed and supplied 3206 kms of 24F HDPE Double Sheath OFC to BSNL within the scheduled delivery period of November 2012. The value of the order was Rs. 15.97 crores which itself is more than the previous two year turnover of the Company. Other than this during the Financial Year 2012-13, the company has executed and supplied various small orders of Indian Railways, private parties etc. The Company will be making operating profit during the year 2012-13.

Regarding the NOFN project of the Government to cover around 2.5 lakh villages of India through broadband, the Government has already formed a Joint Venture Company named M/s. Bharat Broadband Network Limited (BBNL) as a Special Purpose Vehicle. BBNL has floated NIT during first week of April 2013, for supply of 4,04,995 kilometers of 24F HDPE Double Sheath OFC and accessories. The total quantity has been divided into six packages as below:

The total value of the above quantum will be above Rs. 2,000 crores. The project is going to be funded by USOF. After the tender formalities, the order from BBNL is expected during June / July 2013.

M/s. Tamilnadu Telecommunications Limited is proposing to participate in the above tender aggressively. Considering the existing capacity, the company is confident of getting adequate order, utilizing the full plant capacity. This is going to give a good opening for the company to turnaround.

As intimated earlier, the company is also exploring diversified activities. Depending on the feasibility diversification also will be finalized.
