- I.
 - a. The company has maintained proper records showing full particulars including quantitative details and situation of fixed assets.

 - d. The Company had not taken any loan from any company covered in the register maintained under section 301 of the companies Act,1956.

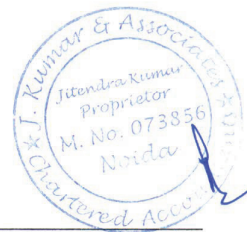
