- The above results were reviewed by the Audit Committee and thereafter approved by the Board of Directors at its meeting held on July 30, 2013. The Statutory Auditors have conducted a "limited review" of the above unaudited financial results..
- The Company's hotel business comprises of one segment only.
- The hotel industry in Goa is subject to seasonality. The financial results for the quarter ended June 30, 2013 do not reflect the normal trend.
- The business operations of the Company's land based casino "Goa Nugget" has been suspended w.e.f. April 24, 2013.
- Under the Company's renovation program, 68 guest rooms and Villas were temporarily closed for renovation w.e.f. July 17, 2013.
- The Company has opted for accounting the exchange difference arising on reporting of long term foreign currency monetary items in line with Notification dated March 31, 2009 and Notification dated December 29, 2011 on Accounting Standard 11. Accordingly in the quarter ended June 30, 2013 the foreign exchange loss of Rs. 43.41 lakhs (as against loss of Rs. 26.51 lakhs in the corresponding previous quarter) on foreign currency loans is capitalised by adding the same to the cost of relevant fixed assets. Provision for Deferred tax will be considered at the year end.
- The unaudited figures of preceding quarter are the balance figures between audited figures in respect of the full year ended March 31, 2013 and published year to date figures upto the third quarter ended December 31, 2012.
- The figures of previous periods have been regrouped wherever required

Our responsibility is to issue a report on these financial results based on our review.

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity." issued by the Institute of Chartered Accountants of India. This Standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with accounting standards referred to in section 211 (3C) of the Companies Act, 1956 and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
