

## Kolte-Patil Developers appoints Shraddha Jain as Chief Financial Officer

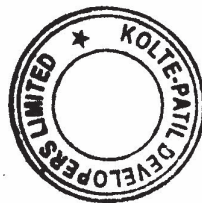
