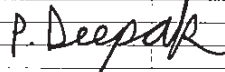

LIMITED REVIEW REPORT FOR THE QUARTER ENDED 30TH SEPTEMBER 2014

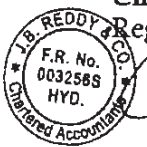
