Quarter ended 30th September, 2014

- Revenue for the quarter has been at Rs.139.82 Crore as against Rs.137.13 Crore in the corresponding quarter registering a growth of 1.96%.
- EBIDTA for the quarter improved to Rs.14.88 Crore as against Rs.7.44 Crore in the corresponding quarter i.e. higher by 100%.
- Profit After Tax for the quarter is Rs.7.32 Crore (after providing Rs.3.49 Crore for Deferred Tax Liability), as against Rs.3.89 Crore in the corresponding quarter registering a growth 88%.

Haif Year ended 30th September, 2014

- Revenue for the half year has been at Rs.294 Crore as compared to Rs.283 Crore in corresponding period registering a growth of 4%.
- EBIDTA for the half year improved to Rs.30.66 Crore as compared to Rs.11.33 Crore in the corresponding period registering a growth of 171%.
- Profit After Tax for the half year is Rs.15.79 Crore, (after providing Rs.7.09 Crore for Deferred Tax Liability) as compared to Rs.4.01 Crore in the corresponding period registering a growth 294%.
