Sub: Intimation under Clause 36 of the Listing Agreement

This is in reference to a Press Release dated 21st December, 2014 issued by the Central Bureau of Investigation, New Delhi, informing that CBI Registered a case against two private companies based at Odisha & Jharkhand and others for alleged irregularities in Coal Block Allocation.

The CBI officials from New Delhi visited the facilities of Electrosteel Castings Limited (ECL) – Head Office at Kolkata, Bokaro Plant, ECL Coal Mine and Electrosteel Steels Limited Registered office in Ranchi on 21st December, 2014. During the course of investigation, the CBI officials requisitioned some original documents related to Parbatpur Coal Block and sale and purchase of clean coal, middlings, jhama & slurry. Electrosteel Castings states that all the requisitioned documents have been submitted to the officials of the Central Bureau of Investigation and reiterated that in future, if there is any query, the same shall be submitted to the CBI and ECL shall continue to extend its co-operation to the investigating authorities.

The said case relates to Parbatpur Coal Block of Electrosteel Castings Limited.

The said Press Release amongst others states that the CBI registered a case under section 120-B r/w 406 & 420 of IPC and under sections 13(2) & 13(1) (d) of PC Act against Electrosteel Castings Limited and Electrosteel Steels Limited and unknown public servants.

The Central Bureau of Investigation in the said case alleged that the Company resorted to sale of 50162.42 Metric Tonnes of middlings dishonestly to another private company based at Jharkhand and disposed-off 42500 Metric Tonnes of inferior ungraded coal, Jhama and slurry to the non-approved end users.
