1. - 2. The Company had appointed NSDL as the service provider, for extending the facility of electronic voting to the shareholders of the Company from 10.00 A.M. on Tuesday, 25th November 2014 to 5.00 P.M. on Wednesday, 24th December 2014. After the date and time fixed for closing of the e-Voting, the site was blocked by us.
- 3. The Management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 and Rules relating to evoting and physical postal ballot on the resolutions contained in the notice to the Postal Ballot of the members of the Company. My responsibility as a scrutinizer for the voting process is restricted to make a Scrutinizer's report.

of the votes cast "In favour" or "against" the resolutions stated above, based on the report generated from the physical ballot paper and e-voting system provided by the NSDL, the Authorized agency engaged by the Company to provide e-voting facilities.

- 4. Accordingly, after completing my detailed verification of both e-voting and physical forms received, I submit my report as under:
 - On 21st November, 2014 the Company had completed the emailing of postal ballot forms to NSDL and on 24th November, 2014 the Company had completed the dispatch of postal ballot forms along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members as on 14th November, 2014.
 - Particulars of all the postal ballot forms received from the Members have been entered in a register separately maintained for the purpose.
 - The postal ballot forms were kept under safe custody before commencing the scrutiny of such postal ballot forms.
 - The details of postal ballot forms and those under e-voting were scrutinized by me and the shareholding was matched / confirmed with the Register of Members of the Company.
