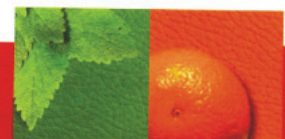

- The above results have been reviewed by the Audit Committee and taken on record by the Board of Directors at its meeting held on Feb.12th, 2014. Pursuant to clause 41 of the Listing Agreement, the Statutory Auditors of the Company have Carried out Limited review of the same.
- The Board of Directors has recommended interim Dividend of Rs 1.40/- (i.e 28 %) per Equity Share of Rs.5/- each of the company as the Third Interim Dividend for the Financial year 2013-14.
- The Company is engaged in production of Coated Textile Fabric hence there is no reportable business segment and the company has no activity outside india except export of Coated Textile Fabric Manufactured in India, thereby no Geographical segment and no segment wise information is reported.
- Other expenses includes exchange rate fluctuation gain of Rs.84.17 Lacs for the Quarter ended 31.12.13 against exchange rate fluctuation loss of Rs.40.17 Lacs in preceding Quarter & loss of Rs.48.00 Lacs in corresponding quarter of previous year.
- Finance cost includes exchange rate fluctuation gain of Rs.82.71 Lacs for the Quarter ended 31.12.13 against exchange rate fluctuation loss of Rs.135.02 Lacs in preceding quarter & Rs. Nil in corresponding quarter of previous year.
- The impact of define benefit plan of Gratuity & Leave Encashment will be Provided at the year end.
- Previous quarter/year figures are re-grouped and rearranged wherever considered necessary.
- Earning per share has been restated due to sub division of one Equity shares of Rs.10/- each into two Equity Shares of Rs.5/-each (w.e.f. 26th Sept.2013)

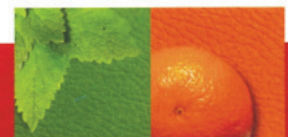

1. We have reviewed the accompanying statement of Unaudited financial results of **Mayur Uniquoters Limited, Jaitpura, Jaipur** ('the Company') for the quarter ended **DECEMBER 31, 2013** (the 'Statement'), except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been reviewed by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on the statement based on our review.

We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, Review of Interim Financial Information Performed by the Independent Auditor of the Entity issued by the Institute of Chartered Accountants of India.
