- 1) In Column no. 5 and 8 of the said Form no. D, it was wrongly mentioned that "Off-market purchase from other member of the Promoter Group through a negotiated private placement", whereas actually Mr. Suresh Gupta and has sold the Shares and it should be "Off-market sale to other member of the Promoter Group through a negotiated private placement".
- 2) In column no 11 of the said Form no D, the sale quantity of shares is 18,84,087 equity shares and not 18,848,047 equity shares.




