## Simplex Infra 03FY14 results

Kolkata, February 14, 2014 – Simplex Infra announced today its standalone unaudited Results for the Quarter and Nine months ended Dec'13.

During the Q3FY14, it achieved Standalone Gross Sales of ₹ 1421 crs against ₹ 1374 crs same quarter last year. EBITDA rose YoY 12% to ₹ 160 cr (₹ 143 cr), EBIT 17% to ₹ 108 cr (₹ 93 cr), PBT 10% to ₹ 20 cr (₹ 18 cr) and PAT 41% to 15 crs (₹ 11 cr).

The order intake during the quarter is ₹. 1611 cr and cumulative upto Dec'13 is ₹.6912 cr.

The order book as of Dec'13 stands at ₹.16708 cr. in addition to the LI status of ₹ 940 cr.

For the Nine Months ended Dec'13 the Standalone Gross Sales is  $\stackrel{?}{\underset{?}{?}}$  4152 crs against  $\stackrel{?}{\underset{?}{?}}$  4410 crs in the same period last year.
