This is in continuation of our letter dated 15 January 2014 regarding seeking approval of the members of the Company by passing of a special resolution through Postal Ballot pursuant to Section 192A of the Companies Act, 1956 read with the Companies (Passing of the Resolution by Postal Ballot) Rules, 2011 and other applicable provisions, if any, of the Companies Act, 1956 and the Companies Act, 2013, along with the rules as may be prescribed therein (including any statutory modification or re-enactment thereof), vide Postal Ballot Notice dated 15 January 2014, for the proposed sale and transfer of Company's Transportation Undertaking to ALSTOM Transport India Limited, as a going concern on a 'slump sale' basis for a lump sum consideration, without values being assigned to individual assets and liabilities. We wish to inform you that, based on the report dated 04 March 2014 submitted by Ranjeet Pandey & Associates, Company Secretaries, the Scrutinizer, the results of the voting conducted through Postal Ballot has been declared by Mr. Patrick Ledermann, Vice-Chairman and Managing Director of the Company on 07 March 2014.
