This is in continuation of our letter dated 16 June 2014 regarding seeking approval of the members of the Company by passing of a special resolution through Postal Ballot pursuant to Section 110 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 (including any statutory modification or re-enactment thereof) for the proposed sale and transfer by the Company of its Auxiliary Components Business (Air preheaters and Industrial Mills business) to OAK Energy India Private Limited as a going concern on a slump-sale basis (as defined under Section 2(42C) of the Income-tax Act, 1961) for a lump sum consideration, without values being assigned to individual assets and liabilities), vide Postal Ballot Notice dated 05 June 2014.
