

**Government to  
 formulate new  
 education policy**

Government plans to formulate a new education policy aimed at meeting challenges posed by lack of quality, research and innovation in educational institutions, minister for human resources development, Smriti Irani said on Wednesday. The National Policy on Education was amended in 1992, has been the guiding document for the policies of the government in this sector. The government has been revisiting the National Policy on Education 1986, as amended in 1992, which provides for national system of education implying that up to the college level, all students, irrespective of caste, creed, religion or sex, have access to education of a comparable quality. The national system of education envisages a common educational structure. The 10+2+3 structure has been accepted in most of the country. But the last few years have seen a change with the emergence of new paradigms such as rights-based approach to elementary education.
