1. In the absence of the Chairman, Lt. Gen D B Singh, took the Chair and introduced the President and the Directors present.
2. The Notice dated 14th June, 2014 convening the Twenty Seventh Annual General Meeting and the related Explanatory Statement and the Directors' Report and Accounts, for the financial year ended 31st March, 2014, as previously circulated, were taken as read. The business before the Meeting was taken up after having established that the requisite quorum for the meeting was present.

The Register of Directors' Shareholding and the Register of Contracts and arrangements in which Directors are interested were placed before the Meeting in accordance with the requirements of Section 170(1) and 189 of the Companies Act, 2013 respectively, and it remained open and accessible during the meeting to all persons attending the meeting.
4. The signed Auditors' Report was kept on the table throughout the Meeting.
5. The Chairman delivered his speech on the occasion of the Twenty Seventh Annual General Meeting.


