

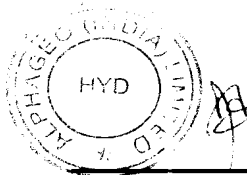

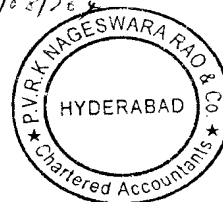

Notes:

- The above Standalone unaudited Financial results for the quarter ended 30th June, 2014, as reviewed by the Audit Committee, were considered and approved by the Board of Directors at its meeting held on 12th August, 2014. The Statutory Auditors have carried out the Limited Review of the above results.
- As per Clause 41 of the listing agreement, the Company has opted to publish quarterly Unaudited Standalone Financial Results and to publish consolidated results at the year end.
- There are no separate reportable primary segments as per Accounting Standard 17 notified under the Companies Act, 2013 as the business of the Company related to one business segment i.e., Seismic Data Acquisition and Related Services.
- The figures for three months ended 31.03.2014 are the balancing figures between audited figures in respect of the full financial year and the published year to date figures upto nine months of the relevant financial year.
- As per the requirement of the Companies Act, 2013 ("the Act"), the Company has computed depreciation on the basis of the estimated economic lives wherever applicable or useful lives of fixed assets in the manner prescribed in Schedule II of the Act. Consequently depreciation for the quarter ended 30th June, 2014 is lower by Rs.8.40 lakhs. Depreciation of Rs.40.48 Lakhs (net of deferred tax) on account of assets whose useful life is already exhausted as on 1st April, 2014 has been adjusted to Retained Earnings.
- The figures for the previous year / period have been reclassified / regrouped wherever necessary to conform to current period's classification

LIMITED REVIEW REPORT

TO
THE BOARD OF DIRECTORS OF

We have reviewed the accompanying statement of unaudited financial results of **ALPHAGEO (INDIA) LIMITED** for the period ended **30th June, 2014** except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors / Committee of Board of Directors. Our responsibility is to issue a report on these financial statements based on our review.

We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, "Review of Interim Financial Information Performed by the Independent Auditor of the Entity" issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the financial statements are free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Based on our review conducted as above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with the accounting standards issued under the Companies (Accounting Standard) Rules, 2006 which continue to apply as per Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014, and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
