Consolidated Financial Highlights for Q1

- ❖ Consolidated total revenue during the quarter increased to Rs. 11369 Lacs from Rs. 9591 Lacs in corresponding Quarter of the previous year depicting a growth rate of 19%.
- ❖ Earnings before interest, tax, depreciation and amortization stood at Rs. 533 Lacs as compared to Rs. 434 Lacs in corresponding quarter of previous year.
