### LIMITED REVIEW REPORT

We have reviewed the accompanying statement of unaudited financial results of Indian Sucrose Ltd. for the period ended 30th June, 2014 except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been audited by us.
