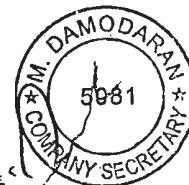

provisions of Section 110 of the 2013 Act read with Rule 22 of the Rules,



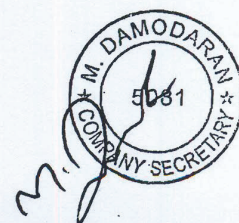
