In terms of Clause 35B of the Listing Agreement and provisions of the Section 108 of the Companies Act, 2013 read with Rule 20 (ix) of Companies (Management & Administration) Rules, 2014 (the Rules), I was appointed as Scrutinizer by the Company on 30th May, 2014 to the e-voting process for passing the resolutions in items numbers 1 to 12 of the Annual General Meeting Notice dated 22nd August, 2014

In terms of the aforesaid Notice, E-Voting was open for three days from 09.00 a.m. on Monday, 15th September, 2014 to till 6.00 p.m. of Wednesday 17th September, 2014 and members were required to cast their votes electronically conveying their Assent or Dissent in respect of the Ordinary/Special Resolutions as contained in Annual General Meeting notice dated 22nd August, 2014, on e-Voting platform provided by Central Depository Service (India) Limited (CDSL).



As required in the Rules, I unlocked the E-Voting on the platform provided by CDSL after the completion of E-Voting process at close on Wednesday in the presence of Ms. Nithya Pasupathy & Mr. Arun Kumar.

Based on the results made available to me, Members have casted their votes on the E-Voting platform and I have annexed with this Report, the details and analysis of the E-voting Results for each of Twelve items.
