
It may be noted that the Special Resolution as set out in the notice has been passed by the members with the requisite majority.

1. In terms of provisions of Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, I was appointed as Scrutinizer by the Company on 19.07.2014 to conduct the voting through Postal Ballot Forms and E-voting for passing of the Special Resolution as contained in the Notice dated 19.07.2014
2. In terms of the aforesaid Notice, members were required to convey their assent or dissent, as the case may be on or before 28<sup>th</sup> August, 2014 in respect of each of the Special Resolutions as set out therein as under:-
  - In case of Postal Ballot Form mailed to them by the Company, in prepaid envelopes addressed to us not later than the close of working hours i.e. at 5.00 p.m. on 28<sup>th</sup> August, 2014.
  - In case of e-Voting, votes to be cast electronically on e-Voting platform provided by Karvy Computershare Private Limited on or before 5.00 p.m. on 28<sup>th</sup> August, 2014
3. We received 222 Postal Ballot Forms and 111 Members cast their votes on the e-voting platform, till 28<sup>th</sup> August, 2014, being the last day for receipt of duly completed Postal Ballot Forms and E-Voting on Karvy portal, as per the said Notice. Postal Ballots subsequently received after the said periods are not considered.

4. In case of E-Voting, Members' demographic details, their voting rights and voting pattern were provided by Karvy Computershare Private Limited
5. The voting rights of the Members were reckoned as on 30.05.2014
