Dear Sir,

Further to our letters dated 15-07-2014 and 30/07/2014 about Postal Ballot Voting, we are to inform you that pursuant to the Scrutinizer's Report, the results of the Postal ballot were declared today i.e. 8<sup>th</sup> September, 2014. As per Scrutinizer's Report 50 numbers of Postal Ballot Forms were received including by evoting for 1,43,29,432 equity shares (Votes) out of which no Postal Ballot Form was rejected.

Out of these 32 ballots for 1,40,81,159 equity shares (Votes) were in favour of the Resolution and 18 ballots for 2,48,273 equity shares (Votes) were against the resolution. Thus there were Ballots (Votes) forming 98.2674% in favour of resolution and 1.7326 % votes against the resolution. On the basis of Postal Ballot Forms received and votes cast, the resolution stands approved as a special resolution. A copy of the Scrutinizer's Report is attached herewith.

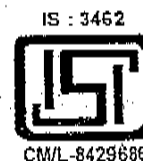

The Board of Directors of the Company at its meeting held on 27<sup>th</sup> May, 2014 has appointed me as the Scrutinizer for conducting the postal ballot voting process including voting by electronic means.

1. The Company has completed the dispatch of postal ballot forms on 30<sup>th</sup> July, 2014 along with postage prepaid business reply envelope to its Members whose name(s) appeared on the Register of Members as on 26<sup>th</sup> July, 2014.
2. The Company completed the mail of postal ballot forms on 30<sup>th</sup> July, 2014 to its Members whose name(s) appeared on the Register of Members as on 26<sup>th</sup> July, 2014.
3. Particulars of all postal ballot forms and vote by electronic means received from the Members have been entered in a register separately maintained for the purpose.
4. The postal ballot forms were kept under my safe custody in sealed and tamper proof ballot box before commencing the scrutiny of such postal ballot forms.
5. The ballot box was opened after the close of working hours on 4<sup>th</sup> September, 2014 in my presence.
6. The votes by electronic means have been unblocked on 5<sup>th</sup> September, 2014.
7. None of the votes by electronic means have been seen invalid.
8. The postal ballot forms were duly opened in my presence and scrutinized and the details of shareholders were matched with the Register of Members of the Company as on 26<sup>th</sup> July, 2014.
9. All postal ballot forms and votes by electronic means, received upto the close of working hours on 4<sup>th</sup> September, 2014, being the last date fixed by the Company for receipt of the forms, were considered for scrutiny.
10. No envelopes containing postal ballot forms were received after close of working hours on 4<sup>th</sup> September, 2014.
