



MINUTES OF THE PROCEEDINGS HELD ON 19TH DECEMBER, 2014 AT 10.00 AM AT THE REGISTERED OFFICE OF THE COMPANY AT NO.146 DR.RADHAKRISHNAN ROAD, CHENNAI 600 004, RELATING TO DECLARATION OF THE RESULT ON THE POSTAL BALLOT PROCESS CONDUCTED THROUGH POSTAL BALLOT (PHYSICAL AND ELECTRONICAL VOTING) PURSUANT TO THE PROVISIONS OF SECTION 110 OF THE COMPANIES ACT, 2013 READ WITH THE COMPANIES (MANAGEMENT AND ADMINSITRATION) RULES, 2014 ON THE SPECIAL RESOLUTION UNDER SECTION 180 (1) (a) AND OTHER APPLICABLE PROVISIONS, IF ANY OF THE COMPANIES ACT, 2013, IN RESPECT OF CLOSURE OF THE BUSINESS WHICH IS BEING CARRIED ON AT WALNUT HOTEL (A UNIT OF SAVERA INDUSTRIES LIMITED) DOOR NO.5/76-4-16 & 17 RAIDURGA, GACHIBOWLI-TOLICHOWKI ROAD, HYDERABAD 500 008, SALE & DISPOSAL OF THE MOVABLE ASSETS SITUATED AT THE PREMISES OF WALNUT HOTEL (A UNIT OF SAVERA INDUSTRIES LIMITED) AND TERMINATE THE LEASE ENTERED FOR WALNUT HOTEL WITH THE LESSOR.

The Managing Director stated that the Company had dispatched on 16.11.2014 to all the shareholders, a Notice dated 5.11.2014 under section 110 of the Companies Act, 2013, for obtaining the consent of the shareholders to the following Special Resolution by means of Postal Ballot / Electronic Voting (e-voting).

## The following item was passed as a Special Resolution.

"RESOLVED that pursuant to provisions of section 180 (1) (a) and other applicable provisions if any of the Companies Act, 2013 consent of the members of the company be and is hereby accorded to the company to close the business which is being carried on at Walnut Hotel, (a unit of Savera Industries Limited) door no. 5/76-4-16 & 17 Raidurga, Gachibowli-Tolichowki Road, Hyderabad 500 008, sell & dispose of the movable assets situated at the premises of Walnut Hotel, (a unit of Savera Industries Limited) door no. 5/76-4-16 & 17 Raidurga, Gachibowli-Tolichowki Road, Hyderabad 500 008 and terminate the lease entered for Walnut Hotel with the Lessor.

RESOLVED FURTHER THAT the Board of Directors of the company be and is hereby authorised to do the deeds, acts and things in connection therewith.

The Managing Director stated that it was mentioned in the said Notice dated 5.11.2014 that the postal ballot form sent therewith should be returned by the Shareholders duly completed to the Scrutinizer not later than the close of working hours (i.e. 18.00 hrs (IST) on 16<sup>th</sup> December, 2014 and in compliance with Clause 35B of the Listing Agreement and Sections 108, 110 and other applicable Provisions of the Companies Act, 2013, read with the related rules, the Company had provided e-voting facility to all its Members, to enable them to cast their votes electronically instead of dispatching the physical Postal Ballot Form by post. The Company has engaged the services of CDSL for the purpose of providing e-voting facility to all its Members and as scheduled the e-Voting period commenced on 17th November, 2014 (9.00 hours IST) and ended on 16th December, 2014 (18.00 hrs. (IST)).
