Mumbai, October 28, 2015: KEC International Ltd. (KEC), a global infrastructure EPC major, an RPG Group company, today announced its unaudited consolidated results for the quarter ended September 30, 2015.

Consolidated Financial Performance

Net Revenue for the quarter stands at ₹ 2,021 crore as against ₹ 2,173 crore in the corresponding quarter of previous year, a decrease of 7% Y-o-Y.

EBITDA for the quarter stands at ₹ 155 crore as against ₹ 121 crore in the corresponding quarter of previous year, an increase of 28% Y-o-Y.

Profit After Tax for the quarter stands at ₹ 44 crore as against ₹ 20 crore in the corresponding quarter of previous year, an increase of 118% Y-o-Y.

New Order Intake

The Company has secured additional new orders of ₹ 555 crore till October 25, 2015 in its Transmission & Distribution and Cables businesses. Details are as follows -

- Secured a 400 kV Transmission Line project order of Rs. 260 crore through Public Private Partnership on DBFOT Basis from Rajasthan Rajya Vidhyut Prasaran Nigam Ltd.
- Secured a GIS Substation order of Rs. 185 crore from PGCIL.
- SAE Towers secured supply orders of Rs. 81 crore in Mexico, Brazil and the US.
- Cables business secured orders of Rs. 29 crore for supply of Power and Telecom cables.

Mr. Vimal Kejriwal, MD & CEO, KEC International Ltd commented, *"We continue to deliver on the profitability front; having successfully achieved an improvement in our margins for 3 consecutive quarters. The revenue for the quarter was slightly impacted primarily on account of softening of the commodity prices and depreciation in foreign currencies (Brazilian Real). I am glad that we have achieved yet another milestone by foraying in the PPP space with an Intra-State Transmission Line Project."*
