- 1) I, Ashish C. Doshi, Partner of SPANJ & ASSOCIATES, Company Secretaries in Practice having office at TF/1, Anison Bldg, 3rd Floor, State Bank of India Lanc, Swastik Soc., Nr. Stadium Circle, C. G.
