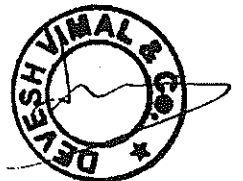

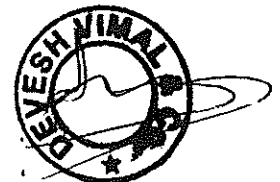

Sub: Scrutinizers Report on e-voting conducted in respect of Public shareholders resolution to be passed through Postal Ballot pursuant to section 108 & 110 of the Companies Act, 2013 ("the Act") and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules") read with Clause 35-B of the Listing Agreement.

- (1) I, Devesh A. Pathak, Practising Company Secretary, has been appointed as the scrutinizer by the Board of Directors of Styrolution ABS (India) Limited, to conduct the electronic voting process in respect of Public shareholders' resolution to be passed through Postal Ballot as set out in the Notice dated 24<sup>th</sup> September, 2015, alongwith statement setting out materials facts under Section 102 of the Act sent to the Shareholders in respect of the subject matter of the resolution as appearing in Clause no. 6 of this Report pursuant to Section 108 of the Act and Rule 20 & 22 of the Rules read with Clause 35-B of Listing Agreement.
- (2) The management of the Company is responsible to ensure the compliance with the requirements of Clause 35-B of the Listing Agreement read with the Act and the rules framed thereunder for providing e-voting facility to its shareholders in respect of the aforesaid resolutions. My responsibility as a Scrutinizer for conducting e-voting process is restricted to report on the votes cast 'in favour' or 'against' the aforesaid resolutions based on the reports generated from the e-voting system provided by National Securities Depository Limited (NSDL), the authorized agency to provide e-voting facilities engaged by the Company.





- (3) The e-voting facility remained open from Saturday, 3<sup>rd</sup> October, 2015 (9.00 a.m.) to Monday, 2<sup>nd</sup> November, 2015 (5.00 p.m.)
