CODE OF INTERNAL PROCEDURES AND CONDUCT FOR PREVENTION OF INSIDER TRADING IN DEALING WITH SECURITIES OF COAL INDIA LIMITED

(PURSUANT TO REGULATION 12(1) OF SEBI (PROHIBITION OF INSIDER TRADING) REGULATIONS 1992- AS AMENDED)

Trading in CIL's shares by the Designated Employees – Closure of Trading Window:-

- In view of declaration of Standalone and Consolidated financial results for the third quarter and nine (9) months ended 31st Dec.' 2014 of financial year 2014-2015 by Coal India Limited Board of Directors

As per the Code of internal procedures and conduct for prevention of Insider Trading (Code) in dealing with Securities of CIL, the Company shall specify a trading period to be called "Trading Window" for trading in the Securities. The trading window shall be closed during the time the information referred to in clause 2.12 of the aforesaid Code is unpublished. Trading window shall be opened 24 hours after the

Price sensitive information referred to in Clause 6.2 of the Code, for which trading window is closed, is made public.

It has been decided that the trading window shall remain closed from **February 5, 2015 to February 13, 2015 (both days inclusive)**. During the restricted period, the Designated Employees(as defined in Clause 2.7 of the said code and as notified vide CIL:XI(D):04161:2011:2456 dated 26/04/2011 in case of employees of subsidiaries) and their dependents shall not deal in the shares of CIL.

All Designated Employees as per the Code and as notified vide CIL: XI (D):04161:2011:2456 dated 26/04/2011 are requested to take note of the above. Heads of the concerned Departments of Coal India Limited are also requested to bring the above circular to the notice of Designated Employees of the respective Departments under their control.

The Company Secretaries of the subsidiary companies viz. ECL, BCCL, CCL, WCL, SECL, NCL, MCL, CMPDIL, being the nodal officer for the purpose of this code, are also requested to bring this circular to the notice of the Designated Employees of their respective companies. They are further requested to arrange to display this circular on the Notice Board of their concerned offices.
