This is in continuation of our communication dated February 23, 2015 and with reference to the postal ballot notice of the Company dated February 13, 2015 (“Notice”).

This is to bring to your attention that we have published today in newspapers Free Press Journal, Navshakti, Financial Express and Jansatta, a notice and corrigendum for the benefit of the members of the Company. The copies of the publications are annexed herewith.

The Notice provided that the issue price would be determined in accordance with Chapter VII of the SEBI ICDR Regulations and the issue price has been determined as such. As undertaken by the Company in the Notice, the issue price determined in accordance with the provisions of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009 (“SEBI ICDR Regulations”) has been notified to the members through the notice and corrigendum.

We would also like to inform you that there was an inadvertent error in Paragraph (d) of the explanatory statement forming part of the Notice, wherein while reproducing an extract of Regulation 76 (1) of the SEBI ICDR Regulations, the regulation as existing prior to an amendment effective August 25, 2014 was inadvertently reproduced and a reference had been made therein to the ‘closing prices’ instead of the ‘volume weighted average prices’.

Accordingly, Paragraph (d) of the explanatory statement forming part of the Notice, which makes a reference to provisions of Regulation 76 (1) should be read as follows:

“The issue of equity shares arising out of exercise of shares issued on preferential basis shall be made at a price not less than higher of the following or as per the law prevailing at the time of allotment of shares:

- i. The average of the weekly high and low of the volume weighted average price of the related equity shares quoted on the recognised stock exchange during the twenty six weeks preceding the relevant date; or
- ii. The average of the weekly high and low of the volume weighted average prices of the related equity shares quoted on a recognised stock exchange during the two weeks preceding the relevant date.”

We have informed the members of this inadvertent error in the attached notice and corrigendum.

All other contents of the Notice remain unchanged.

MCA drops early warning system plan to detect corp frauds

New Delhi, Feb 27: The ministry of corporate affairs has shelved a proposed early warning system to detect frauds at companies following "unsatisfactory results" and continues to analyse findings to check for non-compliance.

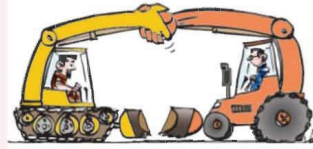
"The ministry had tested an early warning system, developed in-house, during the year 2013-14. This system was dropped on account of unsatisfactory results," corporate affairs minister Arun Jaitley said in a written reply to the Lok Sabha.

To keep a tab on entities violating companies Act, the ministry is analysing various filings made by corporates.

In the last three financial years and period till February 23, 2015, the ministry ordered SFO probe with respect of 184 companies for alleged frauds.

"Non-compliance with the provisions of Companies Act are identified through analysis of certain statements and returns filed by the companies and/or complaints received in the ministry/Serious Fraud Investigation Office, by the concerned Registrars of Companies and SFO," the minister said. **PTI**

Finmin to invite bids for private capital

New Delhi, Feb 27: The finance ministry is all set to invite bids from the private sector companies to infuse capital in 3P India. The entity is being set up to help resolve technical and legal issues faced in the public-private partnerships (PPPs).

Sources said the entity called 3P India announced by finance minister Arun Jaitley in July 2014 to aid "mainstreaming of PPPs" would be set up as a not-for-profit body and will have representation from the private sector and multilateral institutions.

The government will be a minority shareholder in the entity. The Cabinet will approve the final shape of the

The govt will be a minority shareholder in the entity. The Cabinet will soon approve its final shape

entity, which is expected to be led by a leading figure from the private sector.

While announcing the setting up of the agency, Jaitley had committed Rs 500 crore for it. This fund would go to a trust, from which the agency would draw for its expenses. It will have an initial equity base of about Rs 10 crore. 3P India's main tasks include redesigning the PPP model contracts. PPPs, which had

initially took off well in the economic boom years, suffered later on account of the subsequent economic slowdown. Its impact on profit forecasts and souring of relationship between states and private partners. In many cases, it led to litigation and withdrawal of the private partner from the project.

One of the issues affecting infra investments, which also has a bearing on PPPs, is the debt burden of large private players in the business. Scarcity of long-term funding is another. The country has over 900 PPPs now.

3P India, to be set up along the lines of Partnerships UK, founded by Britain to facilitate PPPs, will help in framing of PPP policy and guide businesses through the project. Jaitley had said along some of India's iconic infrastructure like airports, ports and highways, there has been a weaknesses in its framework due to rigidity in the contractual arrangements.

Jaitley wants more sophisticated model contracts and a quick dispute redressal mechanism.

Please note that while the Notice provided that the issue price would be determined in accordance with Chapter VII of the SEBI ICDR Regulations and the issue price has been determined as such, there was an inadvertent error in Paragraph (d) of the explanatory statement forming part of the Notice, wherein while reproducing an extract of Regulation 76 (1) of the SEBI ICDR Regulations, the regulation as existing prior to an amendment effective August 25, 2014 was inadvertently reproduced and a reference had been made therein to the "closing prices" instead of the "volume weighted average prices".

Accordingly, Paragraph (d) of the explanatory statement forming part of the Notice, which makes a reference to provisions of Regulation 76(1) should be read as follows:

"The issue of equity shares arising out of exercise of shares issued on preferential basis shall be made at a price not less than higher of the following as per the law prevailing at the time of allotment of shares:

- The average of the weekly high and low of the volume weighted average price of the related equity shares quoted on the recognised stock exchange during the twenty six weeks preceding the relevant date; or
- The average of the weekly high and low of the volume weighted average prices of the related equity shares quoted on a recognised stock exchange during the two weeks preceding the relevant date."

All other contents of the Notice remain unchanged.
