## Review of financial performance for the Third quarter ending 31st December, 2014

#### Consolidated Quarter review - (Q- o -Q) (Q 3 2014-15 vs Q 2 2014-15)

- PAT for the quarter stood at Rs. 4.58 crore as compared to Rs. 3.73 crore during the preceding quarter, up by 22% Q-o-Q.
- PBT for the quarter was at Rs. 5.84 crore as compared to Rs.5.24 crore during the previous quarter increasing by 11%Q-o-Q.
- EBITDA for the quarter was at Rs. 7.43 crore as compared to Rs.6.63 crore in the previous quarter up by 12% Q-o-Q.
- Total Revenues for the quarter was Rs. 57.05 crore as compared to Rs. 58.21 crore down by 2% Q-o-Q.

### Consolidated Quarter review (Y-o-Y) (Q3 2014-15 vs Q3 2013-14)

- PAT for the quarter under review stood at Rs. 4.58 crore as compared to Rs. 3.59 crore during the same period in the previous year, up by 27%.
- PBT was at Rs. 5.84 crore for the quarter under review as compared to Rs.4.61 crore during the corresponding quarter in the previous year up by 26 %.
