In the case of the Group, since there was no such dispute pending in any of the states and no demand whatsoever has been raised/received, no effect has been given on the working results on account of above judgment. The Group is currently evaluating the above judgment. This is subject matter of qualification by the auditors in the limited review report on the financial results of the Group for the quarter ended December 31, 2014.
- 7 Subsequent to the quarter ended December 31, 2014, Spice Digital Limited, a subsidiary of the Company has acquired 38.53% stake in Anytime Learning Private Limited.

Limited Review Report

Review Report to The Board of Directors Spice Mobility Limited

- 1. We have reviewed the accompanying statement of unaudited consolidated financial results of Spice Mobility Limited Group comprising Spice Mobility Limited ('the Company') and its subsidiaries (together, 'the Group'), for the quarter ended December 31, 2014 (the "Statement"), being submitted by the Company pursuant to the requirement of Clause 41 of the Listing Agreement, except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been reviewed by us. This Statement is the responsibility of the Company's management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, Review of Interim Financial Information Performed by the Independent Auditor of the Entity issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.
- 3. We did not review the statement of unaudited financial results of 21 subsidiaries, whose unaudited financial results reflect total revenue of Rs. 4,399 lacs for the quarter ended December 31, 2014 and total assets of Rs. 10,835 lacs as at December 31, 2014. The financial information for 13 subsidiaries has been taken based on the management certified accounts and for 8 subsidiaries has been reviewed by other auditors whose reports have been furnished to us, and our conclusion on the quarterly financial results is based solely on the reports of the other auditors / management certified accounts.

Basis for qualified conclusion

- 4. As detailed in Note 6 to the unaudited financial results, during the quarter, the Hon'ble Supreme Court of India has given a judgment in the case of State of Punjab Vs. Nokia India Pvt. Ltd. that sales tax on battery charger sold along with mobile phone should be charged at sales tax rate applicable to chargers, which is higher than the sales tax rate applicable to mobile phones in few states. The Group is currently evaluating impact of the judgment and has not estimated additional sales tax amount in this regard as at December 31, 2014 and accordingly has not recorded a provision for such additional sales tax and upon which we are unable to comment on.
- 5. Based on our review conducted as above except for the possible effects of our observation in para 4 above, and on consideration of reports of other auditors on the unaudited separate quarterly financial results and on the other financial information of the components, nothing has come to our attention that causes us to believe that the accompanying Statement of unaudited consolidated financial results prepared in accordance with recognition and measurement principles laid down in Accounting Standard 25 Interim Financial Reporting specified under the Companies Act,1956 (which are deemed to be applicable as per Section 133 of the Companies Act, 2013, read with rule 7 of the Companies (Accounts) Rules, 2014) and other recognized accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.

Limited Review Report

Review Report to The Board of Directors Spice Mobility Limited

- 1. We have reviewed the accompanying statement of unaudited financial results of Spice Mobility Limited ('the Company') for the quarter ended December 31, 2014 (the "Statement"), except for the disclosures regarding 'Public Shareholding' and 'Promoter and Promoter Group Shareholding' which have been traced from disclosures made by the management and have not been reviewed by us. This Statement is the responsibility of the Company's management and has been approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
- We conducted our review in accordance with the Standard on Review Engagements (SRE) 2410, Review of Interim Financial Information Performed by the Independent Auditor of the Entity issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Statement is free of material misstatement. A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

Basis for qualified conclusion

- 3. As detailed in Note 2 to the unaudited financial results, the Company has not made any provision for diminution in the value of investment in equity shares of Rs.8,784 lacs and unsecured interest free loans (including interest accrued thereon) of Rs.25,000 lacs given to Hindustan Retail Private Limited, a wholly owned subsidiary of the Company and its subsidiary, whose net worth has been fully eroded on consolidated basis. We are informed that the Company is in the process of evaluating /reviewing the said diminution in the value of investments and loans given. In our opinion, these have to be fully provided for and had the same been considered the loss would be higher by Rs.33,784 lacs with corresponding impact on the reserves.
- 4. Based on our review conducted as above, except for the effects of our observation in Para 3 above, nothing has come to our attention that causes us to believe that the accompanying Statement of unaudited financial results prepared in accordance with recognition and measurement principles laid down in Accounting Standard 25 "Interim Financial Reporting", [specified under the Companies Act, 1956 (which are deemed to be applicable as per Section 133 of the Companies Act, 2013, read with rule 7 of the Companies (Accounts) Rules, 2014)] and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
