In response to queries from some of our Shareholders and media reports in regard to the aforesaid matter and pursuant to the applicable provisions of the Listing Agreement and other applicable provisions, if any, we would like to hereby inform you as follows:

Further to the advance Intimation by Hinduja Power Limited, Mauritius dated 10<sup>th</sup> March 2015 under Regulation 10(5) of SEBI (SAST) Regulations, 2011 about their proposed acquisition of GOCL shares on 17<sup>th</sup> March, we have been informed by Hinduja Power Limited, Mauritius (HPL), the Acquirer, that they have on 17<sup>th</sup> March 2015 acquired 2,97,18,167 equity shares of our Company from Gulf Oil International (Mauritius) Inc. (GOIMI) by way of Inter-se transfer of shares between the Promoter Group entities pursuant to the provisions of SEBI (SAST) Regulations, 2011. This transaction was effected by way of bulk/block deal on BSE Limited.


We would like to intimate that both the Acquirer (HPL) and the Seller (GOIMI) belong to the Promoter Group.
