Sub: Scrutinizer's Report on Postal Ballot & E-voting conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014

I, Manoj Kumar Banthia, Proprietor of M/s MKB & Associates, Practicing Company Secretary, appointed by the Board of Directors of Hindusthan National Glass & Industries Limited (the Company) to act as the Scrutinizer for the purpose of scrutinizing the Postal Ballot & E-voting process conducted pursuant to the provisions of Section 110 of the Companies Act, 2013 (Act) read with Section 108 of the Act, Rule 22 of the Companies (Management and Administration) Rules, 2014 and Clause 35B of the Listing Agreement, in respect of the Resolutions mentioned in the Postal Ballot Notice dated 11th February, 2015 (Notice), do hereby submit my report as follows:

The Notice along with the Statement under Section 102 of the Act setting out all material facts in respect of Resolutions mentioned therein were sent by the Company electronically by email and physically by Registered Post to the members whose names appear in the register of members/ List of Beneficial Owners as received from the National Securities Depository Limited (NSDL) & Central Depository Services (India) Limited (CDSL) as on 6th February, 2015.

(a) E-voting:

- i. The e-voting services were provided by Central Depository Services (India) Limited (CDSL)
- ii. The electronic transmission of the Notice to the registered email id of the Members was completed on 24th February 2015.
- iii. Voting rights were reckoned on the shares registered in the names of the Members as on Friday, 6th February, 2015.
- iv. The period for e-voting had commenced at 10.00 a.m. on Friday, 27th February, 2015 and ended at close of working hours i.e. 6.00 p.m. on Saturday, 28th March, 2015.

- v. The votes cast were unblocked on Monday, 30th March, 2015 at 9.00 a.m. in the presence of 2 witnesses, Mrs. Sonam Lakhota and Mrs. Swetha Mukherjee, who are not in the employment of the Company.
- vi. The results of e-voting are based on the reports generated from CDSL's e-voting website <https://www.evotingindia.com>.

(b) Physical Ballots:

- i. The Company had dispatched the Postal Ballots, along with the Notice, the Postal Ballot forms along with self-addressed postage prepaid business reply envelope by Registered Post on 24th February, 2015 to the members of the Company whose names appear on the register of members/ List of Beneficial Owners as received from the National Securities Depository Limited (NSDL) & Central Depository Services (India) Limited (CDSL) as on 6th February, 2015.
- ii. The Postal Ballot forms were opened on 30th March, 2015 in my presence and scrutinized by me. The signature of shareholder, shareholding and other details was matched /confirmed with the assistance of M/s Maheshwari Datamatics Pvt.Ltd, Registrar and Transfer Agent of the Company.
- iii. All Physical ballot forms received up to the close of the working hours i.e. 6.00 pmon Saturday, 28th March, 2015, being the last date and time fixed by the Company for receipt of the Ballot Forms were considered for my scrutiny.
- iv. I did not find any defaced or mutilated ballot paper.
- v. The Company in aggregate has received 63 Postal Ballot forms representing 6974 shares in the Company out of which 8 Postal Ballot forms representing 347 shares were invalid and in some of the resolutions, shareholders have opted not to vote/voted partially.

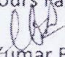

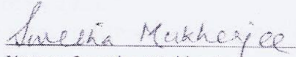
