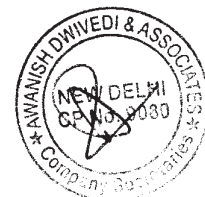
Dear Sir,

The votes were unblocked on Thursday 19th March, 2015 in the presence of 2(two) witnesses Ms. Neha Bhardwaj and Mr. Ashutosh Kumar, who are not in the employment of the company.

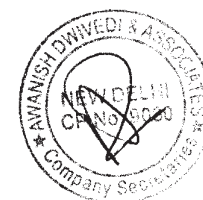

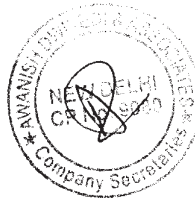
