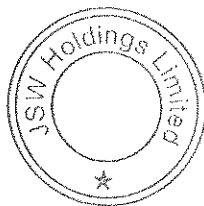

Closure of Trading Window as per JSWHL - Code of Conduct for Prohibition of Insider Trading ("Code")

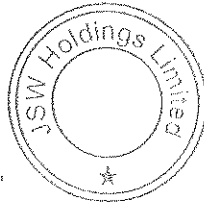
