- 1. - 2.2. The E-voting commenced from 29March 2015 at 10.00 AM and ended on 31 March 2015 at 5.30 PM.
- 2.3. Particulars of all postal ballot forms received from the members have been entered in a register separately maintained for the purpose.
- 2.4. I have downloaded the date of E-voting after the E-voting module was disabled by the Central Depository Services India Limited (CDSL) on 31 March 2015 at 5.45 PM.







- 2.5. The postal ballot forms were kept under my safe custody in sealed and temper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 2.6. The E-voting data were unblocked on 31 March 2015 after 5.30 PMin the presence of two witnesses, **Miss. Anju Arora & Mr. Arvind Kumar Yadav** who are not in employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.
