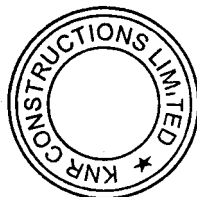



The Performance Security shall be valid until 60 (sixty) days after the Defects Liability Period (Refer Article-7 of RFP Vol.-II).
