**Subject: Postal ballot process under Section 110 of the Companies Act, 2013 -
Scrutiniser's report**

1. Your Board of Directors, by a resolution passed on 25th February 2015, initiated a postal ballot process for appointment of Sri B Muthuraman as an Independent director for a period of five years from 16th April 2015 to 15th April 2020, and appointed me as the Scrutiniser.
2. The company provided e-voting facility for the postal ballot process on the electronic voting platform of National Securities Depository Limited (NSDL), and intimated availability of e-voting facility to the members in the notice of postal ballot.
3. Despatch of notices of postal ballot to all the 39,724 members whose names appeared in the Register of Members / Record of Depositories as on 6th March 2015, the cut-off date fixed for the purpose, was completed by 13th March 2015 in the following manner:
 - (a) By e-mail (sent by NSDL) to the registered e-mail address of 19,882 members.
 - (b) Through registered post (by the RTA) to 19,835 members.
4. NSDL has informed that in case of 7 members e-mail addresses were invalid and in case of 27 members the emails sent bounced back.
5. The company has intimated the postal ballot process and sent the notice of postal ballot to the National Stock Exchange of India Limited and BSE Limited, where its securities are listed.
6. The company has also served the notice of postal ballot to all directors and the auditors of the Company.
7. The company has published advertisements about having despatched the postal ballot notices and ballot forms, on 14th March 2015, in the following newspapers:
 - (a) "Economic Times", a national English newspaper, in English.
 - (b) "Dinamalar", a Tamil newspaper circulating in the State of Tamilnadu, where the registered office is situated, in Tamil.
8. The last time and date for receipt of physical postal ballots was fixed as 6 P.M. on Monday, **13th April 2015**. The E-Voting period commenced on Saturday, **14th March 2015**, at 9 A.M. and ended on Monday, **13th April 2015**, at 6 P.M.

9. All the physical postal ballot forms received upto that time which were opened in my presence and scrutinised. I did not receive any postal ballot forms were after that date and time, also did not receive any mutilated postal ballot forms.
10. After completion of the E-voting period I have unblocked the votes cast in the presence of two witnesses not in the employment of the company and generated the e-voting report from the e-voting website of NSDL.
11. Contents of the physical postal ballots and the e-voting report furnished by NSDL were recorded in a separate register maintained for the purpose in electronic form.
12. A summary of the votes cast on physical postal ballots as well as through e-voting is given below:


