Sub: Intimation of Postal Ballot Result

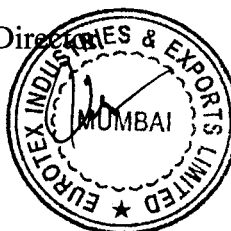

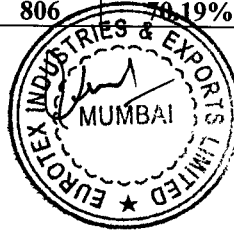

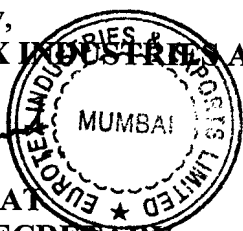

Dear Sir,

I, **Dr. S. K. Jain**, Practicing Company Secretary, appointed as Scrutinizer by the Company's Board of Directors ("the Board") of **M/s Eurotex Industries and Exports Limited** for seeking approval of the Shareholders by way of Special Resolutions for authorizing the Board to the:

- (i) Adoption of New Memorandum and Articles of Association of the Company as per provisions of Companies Act, 2013.
- (ii) Appointment of Shri K. K. Patodia as Chairman & Managing Director.
- (iii) Appointment of Shri Narayan Patodia as Managing Director.
- (iv) Appointment of Shri Rajiv Patodia as Executive Director.

I hereby submit my Report as under:-

- a. I had given my consent to act as Scrutinizer for the said Postal Ballot process vide my letter dated 14th February, 2015.
- b. The Company had offered e-voting facility as an alternative to all its Members, which enabled the Members to cast votes electronically instead of physically submitting dully filled in Postal Ballot Form. The instructions on e-voting were provided in the Postal Ballot Notice dated 14th February, 2015.



c. As per Postal Ballot Notice dated 14/02/2015, the cut-off date (Record Date) was fixed on 20th March, 2015. We have been provided the following details from the Company/M/s Datamatics Financial Services Ltd (R&T) :

- (I) The Company has completed dispatch of Postal Ballot Notices along with draft Resolutions, Explanatory Statements, Postal Ballot Forms and Postage Prepaid Business Reply Envelopes by 7th April, 2015.
- (II) In the Postage Pre- Paid Business Reply Envelope the address of my Office i.e. 13/16, Kapadia Chambers, Ground Floor, 599, J.S.S Road, Chira Bazaar, Mumbai- 400 002 was given and hence the same were delivered to me.
- (III) There were 7,060 Shareholders as on 20/03/2015 out of which 3,604 Shareholders were having Demat Accounts with Depository Participants and 3,456 Shareholders were holding Shares in physical form.
- (IV) 1,655 Shareholders had registered their e-mail id with M/s Datamatics Financial Services Ltd (R&T) and to these Shareholders whom Postal Ballot Notice were sent through e-mail on 8th April, 2015.
- (V) Out of 1,655 Shareholders to whom Postal Ballot Notice were sent through e-mail, 272 e-mails were bounced back.
- (VI) The Company has provided Certificate from Tej Couriers, having its address at 517, E, Pune-bangalore Road, Kolhapur – 416 001 confirming that they have received 5405 Articles from M/s Eurotex Industries And Exports Limited and they had completed dispatch of all the Articles on 07/04/2015. The 7,060 Articles



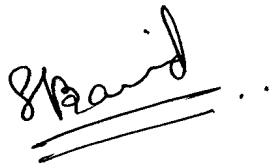
were inclusive of 272 Articles earlier sent through emails and have bounced back.

(VII) We have received a certificate from Tej Couriers that out of 5405 Articles sent by them to the shareholders, delivery of 1566 Articles could not be made and the said Article returned undelivered due to reasons as given in the statement annexed thereto.

d. A Public Notice that the Company had sent Postal Ballot Notices along with other documents to the Shareholders was published in The Free Press Journal (English Newspaper) in Mumbai and Navshakti (Regional Language) Newspaper in Mumbai on Thursday, 9th April, 2015.

e. **E-Voting**

The Company provided E-Voting facility through CDSL portal on www.evotingindia.com under Electronic Voting Sequence Number (EVSN) 150320008. The E-Voting commenced from 15th April, 2015 at 10.00 A.M. and closed on 16th May, 2015 at 6.00 P.M. The votes cast were unblocked on Saturday, 16th May, 2015 at 6.00 P.M. in the presence of two witnesses, Ms Varsha Baid and Mr Sanjay Dadhich who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.

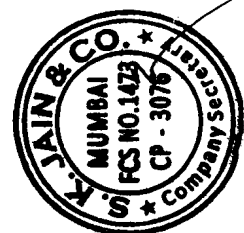


f. **Voting through Postal Ballot Forms**

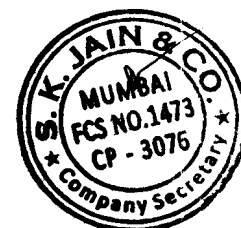

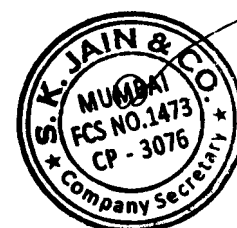

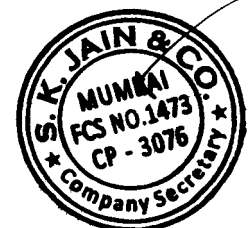

Based on above, I report that all the following four Resolutions which were proposed to be passed through Postal Ballot as Special Resolutions have been passed with requisite majority.

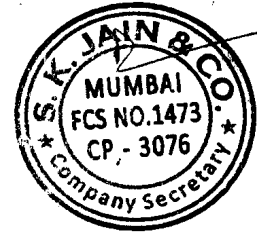

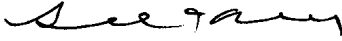
