Receives SGD 111 Million as Consideration

Gurgaon, India, May 12, 2015- Fortis Healthcare International Pte Ltd, a step down subsidiary of Fortis Healthcare Ltd (Fortis), confirmed that it has received the sum of SGD 111 Mn from the sale of its Singapore based RadLink-Asia Pte Limited and its subsidiaries to Fullerton Healthcare Group Pte. With this, the deal announced on May 1, 2015, now stands completed.
