**Code of Practices and Procedures for Fair Disclosures of
Unpublished Price Sensitive Information**

This documents forms the Code of Practices and Procedures for Fair Disclosure of Unpublished Price Sensitive Information ("Code") adopted by ZODIAC-JRD-MKJ LIMITED (ZJML). This Code is consistent with the Securities and Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015.

The Company shall follow the Principles of Fair Disclosures detailed hereunder :

- 1) To promptly make public disclosure of unpublished price sensitive information (herein after called ("UPSI") that would impact price discovery no sooner than credible and concrete information comes into being in order to make such information generally available.
- 2) To make uniform and universal dissemination of UPSI to avoid selective disclosure.
- 3) The Director to be Chief Investor Relations Officer to deal with dissemination of information and disclosure of UPSI.
- 4) To promptly disseminate UPSI that gets disclosed selectively, inadvertently or otherwise to make such information generally available.
- 5) To make appropriate and fair response to queries on news reports and requests for verification of market rumours by regularly authorities.
- 6) To ensure that information shared with analysts and research personnel is not UPSI.
- 7) To develop best practices to make transcripts or records of proceedings of meetings with analysts and other investor relations conference on the official website to ensure official confirmation and documentation of disclosures made.
- 8) To handle all UPSI on a need-to-know basis.
