

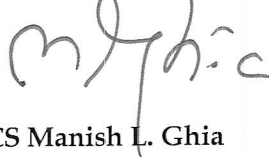

1. The Postal Ballot voting process has been completed and now I submit my report as under:
    - 1.1 The Company completed the dispatch of Notice of Postal Ballot dated 15<sup>th</sup> May, 2015 along with Postal Ballot Form and self-addressed business reply envelope to its members, whose names appeared in the Register of Members as on 15<sup>th</sup> May, 2015.



- 1.2 The e-voting period commenced on Monday, 25<sup>th</sup> May, 2015 (10.00 a.m.) and ended on Tuesday, 23<sup>rd</sup> June, 2015 (05.00 p.m.).
  - 1.3 Particulars of all the Postal Ballot Forms received from the members have been entered in a register separately maintained for the purpose.
  - 1.4 All Postal Ballot Forms received upto the close of working hours of 23<sup>rd</sup> June, 2015, being the last date and time fixed by the Company for receipt of the forms, are considered for my scrutiny.
  - 1.5 The Postal Ballot Forms were duly opened on 24<sup>th</sup> June, 2015 in my presence and scrutinized. The shareholding was matched / confirmed with the Register of Members of the Company / list of beneficiaries as on 15<sup>th</sup> May, 2015.
  - 1.6 The data for e-voting was downloaded on 24<sup>th</sup> June, 2015 (11.30 a.m.) after the e - voting module was disabled by the National Securities Depository Limited (NSDL) Limited.
  - 1.7 The e-voting data was scrutinized for verification of votes cast in favour and against the resolution.
  - 1.8 The Company did not receive any envelope containing Postal Ballot form after 23<sup>rd</sup> June, 2015.
  - 1.9 702 envelopes were returned undelivered containing Postal Ballot Form.
