- I, Suresh Kumar Kabra, Partner, Samdani Kabra & Associates, Company Secretaries, have been appointed as a scrutinizer by the Board of Directors of FAG Bearings India Limited (the Company), for scrutinizing postal ballot voting including voting by electronic means in respect of the passing of the resolution contained in the notice dated 27th May, 2015 through postal ballot as follows:-
 - Approval of scheme of Amalgamation between FAG Roller Bearings Private Limited (FRB) and the Company
