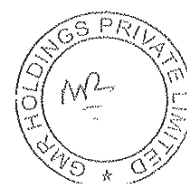

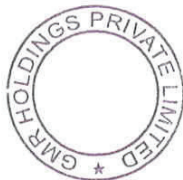


days prior to the date when the investors become entitled to apply for conversion of CCPS, therefore not included in the total diluted capital.
